

#### <u>Main Ideas</u>

-Individualism and social Darwinism shaped Americans' attitude towards society.

-Artists and writers began portraying life in America more realistically, and cities offered new forms of entertainment.

-Two major parties were closely competitive in the late 1800s; tariff rates and big business regulation were hotly debated political issues.



-Reformers developed new methods and philosophies for helping the Urban poor.


#### The Gospel of Wealth

#### **Vocabulary**

**Gilded Age:** Might appear to sparkle, but critics pointed to corruption, poverty, crime, and great disparities in wealth between the rich and the poor.

**Individualism:** Americans firmly believed that no matter how humble their origins, they could rise in society and go as far as their talents and commitment would take them.

**Social Darwinism:** Loosely derived from darwin's theories, strongly reinforced the idea of individualism.

Gospel of Wealth: Andrew Carnagie advocated a gentler version of Social Darwinism

**Philanthropy:** Providing money to support humanitarian or social goals.

Mark Twain: An incomparable American genius.

**Social Gospel:** Movement worked to better conditions in cities according to the biblical ideals of charity and justice.

**Settlement House:** An Institution located in a small neighborhood that provided numerous community services such as medical care, child care, libraries, and classes in english.

Jane Adams: Opened the famous Hull House in Chicago in 1889.

Americanization: Teaching immigrants english and American history & culture.
